## 1. Toegang

4. Ek gee verder toestemming dat:

# INDEMNITY FORM

## 1. Admission

- 1.1 Right of admission reserved.
- 1.2 All persons and children of Raasbekkies Pre-primary School do so entirely at own risk.
- 1.3 Every person who enters Raasbekkies Pre-primary School property inclusive of parents, children and any other person undertakes to adhere to all rules and regulations stipulated below.

## 2. General Indemnity

No child will be allowed to enter Raasbekkies Pre-primary School unless the Indemnity Form has been completed and submitted.

1. I am aware that Raasbekkies Pre-primary School from time to time arranges embussing, excursions, educational visits pertaining to the curriculum and activities of the school.
2. I realise that although the school undertakes every possible precaution to secure my child's safety during school hours and during activities, Raasbekkies Pre-primary School can not guarantee my child's safety at all times.
3. I herewith give permission for my child to participate in any organised activity arranged by the school and all normal curriculum activities of the school. Should I wish to withdraw my permission or prohibit my child from participation during any activity pertaining to normal curricular school activities I will notify the school in writing.
4. I further give permission for:
  - 4.1 Should my child for any reason whatsoever have to be transported in a case of an emergency or any other activity, my child may be transported by an official person designated or employed or other parent of the Pre-primary School with whom an arrangement has been made.
  - 4.2 Should my child require medical treatment and the Pre-primary School after several attempts fail to reach the designated contact person (whose name and details appear on the entry form) the head of school or designate may give permission for medical treatment.
5. I declare that as far as I know my child is physically able to participate in any normal activities provided by the school and is in good health. I also declare that I have informed the School of all relevant facts pertaining to my child's physical activities and health.
6. I accept that I will be held responsible for the payment of any costs incurred for medical or hospital treatment for an injury incurred by my child.
7. I indemnify the School and personal of any claims or responsibility that may arise from damage or loss of property, bodily injuries, illness or death of me or my child during participation of any activity (including transport of my child) or curriculum activities of the school.
8. I am aware of that should my child participate in extra mural or outside curricular activities the School will not be held responsible for my child's safety and well being, although all necessary precautions are taken. I indemnify and will not hold responsible the School, its personal and employees for any damages and loss of property incurred, bodily harm, illness and death of my child during participation in any extra mural or outside curricular activities that takes place outside of the normal business premises of the Pre-primary School (whether this takes place during or outside of school hours) irrelevant if this is incurred or caused by the actions of indemnified persons.
